

Infinitus 2010 Kids' Track Parent Agreement

All Attendees must be accompanied by a his or her parent(s), legal guardian(s) or Authorized Child's Chaperone (as defined herein), (the "Registering Adult(s)") during sign-in, and can only be signed out by the same individual(s), who must provide photographic proof of identification upon drop-off and pick-up. No child will be released on his or her own, or to any third party.

Our goal in the Infinitus 2010 Kids' Track is to provide our attendees with an exemplary Harry Potter experience. Once you have read the following information, please sign, date and return the registration form prior to the first session on July 15, 2010 at 9:00 a.m. No kids' track registration will be considered complete and/or final, nor will any child be allowed to participate in the Infinitus 2010 Kids' Track programming prior to receipt of this signed release. Please understand that HPEF, Inc. and Infinitus 2010 make **no exceptions** to the following conditions.

1. Only a child's parent(s) or legal guardian(s) or Authorized Child's Chaperone may register a child for the Infinitus 2010 Kids' Track.
2. Participation in the Infinitus 2010 Kids' Track is solely at the risk and liability of the parent or legal guardian registering the child.
3. If an emergency or illness occurs while your child is participating in the Infinitus 2010 Kids' Track, you will be contacted by the means provided below.
4. Infinitus 2010 Kids' Track staff and/or volunteers may not administer any medication to any child. If the child has a pre-existing condition requiring or a need for prescribed medication, please ensure that the parent or guardian is able to satisfy these needs either prior to or after the day's session.
5. For the welfare of everyone, if your child is sick during Infinitus 2010, please keep him or her home or in your hotel room for the day.
6. The Infinitus 2010 Kids' Track hours are 9:00 a.m.-12:00 p.m. and 1:30 p.m.-5:00 p.m. on Friday (July 16) and 10:00 a.m.-12:00 p.m. and 1:30-5:00 p.m. on Saturday (July 17)
7. Please make arrangements to arrive no earlier than 10 minutes prior to the commencement of Kids' Track programming, and to retrieve your child no later than 10 minutes after the scheduled conclusion of Kids' Track programming. A late pick up fee of \$1 per minute per child will be charged for any child where the Registering Adult(s) is not in line to pick up said child by 12:10 PM, or 5:10 PM. Children can be picked up early.
8. The parent or legally recognized guardian must stay in the Infinitus 2010 conference area while their child is in the Infinitus 2010 Kids' Track.
9. For everyone's protection, only Infinitus 2010 Kids' Track staff and volunteers are allowed in the Kids' Track area. If you would like to volunteer in the Kids' Track room, please email us at volunteers@infinitus2010.org by May 31, 2010. All Kids' Track staff and volunteers will be subject to background checks.
10. We must have contact information to reach you while you are at Infinitus 2010. The Registering Adult(s) is required to have a working cell phone on him or her at all times.
11. Any personal belongings of the registered child or the parent or guardian that enter the Infinitus 2010 Kids' Track area remain the sole responsibility of the child, parent, or guardian. HPEF, Inc and Infinitus 2010 shall not be responsible for lost, stolen, or damaged property or belongings.
12. The parent or guardian acknowledges and agrees that he/she will be liable for any property damage or personal injury claims arising from the acts of his/her child at/during the Kids' Track.
13. The parent or guardian gives permission for his/her child to receive emergency medical care if needed. Children that are not fully potty trained are not eligible for the Kids' Track.
14. We reserve the right to modify the terms of this Agreement.
